LICENSE AGREEMENT

CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS. IF LICENSEE OBJECTS TO ANY TERM OR CONDITION, KEYSTONE MUST BE IMMEDIATELY NOTIFIED IN WRITING.

1. ENTIRE AGREEMENT. Licensee acknowledges that Licensee has read this agreement and understands this agreement (the Agreement) is the final, complete and exclusive statement of the entire agreement between Keystone Systems, Inc. (Keystone Systems) and Licensee. This Agreement supersedes any prior and contemporaneous proposals, purchase orders, advertisements, and all other communications in relation to the subject matter of this agreement, whether oral or written. No terms or conditions, other than those contained in this Agreement, and no other understanding or agreement which in any way modifies these terms and conditions, shall be binding unless made by a written agreement, executed by duly authorized representatives of parties.

2. DEFINITIONS. “Licensed Software” means, collectively, all computer software delivered, the accompanying data bases and incidental files, and any data bases and incidental files created from time-to-time by such software. “Documentation” means the all delivered user manuals and support documentation supplied with the Licensed Software. “Executable Files” means the compiled binary executable (e.g. .EXE) portions of the Licensed Software. “Data Base Files” means the data base portions of the Licensed Software which contain Licensee’s specific data information. References to Licensed Software are intended to include Executable Files and Data Base Files.

3. LICENSED SOFTWARE AND DOCUMENTATION LICENSE. Keystone Systems hereby grants Licensee a non-exclusive, non-transferrable and perpetual license to use the Licensed Software and the Documentation, subject to the limitations set forth in this Agreement (the License).

The License is a NETWORK License for one (1) integral set(s) of Data Base Files.

Network Licenses. Licensee may copy and install the Executable Files on one or more computer central processing units (“CPUs”) if such CPUs are located, and are physically operated, at a single site within the same physical building; provided that all such CPUs shall access not greater than the number of Data Base Files identified above. Licensee may permit other persons the limited right to operate such installations of the Executable Files in accordance herewith during the term hereof, provided that Licensee shall be responsible for such use and any acts taken by such persons with regard to their access to the Licensed Software. Licensee shall be responsible for monitoring and documenting installations and compliance with the License, and Keystone Systems may review such documentation at any time upon request.

4. OWNERSHIP AND TERMINATION. All right, title and interest to the Licensed Software and the Documentation are, and shall remain, in Keystone Systems. Licensee has no right of access to the source code of the Licensed Software unless a separate Software Escrow Agreement has been validated. Licensee is not entitled to updates or upgrades of the Licensed Software or Documentation unless the optional Maintenance Addendum has been validated. Licensee may not alter, assign, create derivative works, decompile, disassemble, distribute, lease, modify, reverse engineer, sublicense, transfer or translate in any way the Licensed Software or Documentation; provided, that Licensee may permanently and simultaneously transfer all of the Licensed Software, Documentation and the License (but not its liability for breach hereof) if Licensee: a) delivers to the transferee the Licensed Software and Documentation; b) notifies Keystone Systems in writing of such transfer; and c) destroys any archival/backup copy. Licensee agrees that the transferee must expressly accept all terms and conditions of this Agreement.

Except to the limited extent provided for Network Licenses, Licensee MAY NOT COPY the Licensed Software or Documentation; however, that Licensee may make one (1) copy of the Licensed Software for archival/backup purposes and may copy all or portions of the Licensed Software as part of its systematic backup/archival routines as long as any such copies are used only as replacement security for the Licensed Software.

If the Licensed Software or Documentation is used in any way not expressly and specifically permitted by this License, then the License shall immediately terminate, and, upon such termination, Licensee shall thereafter make no further use of the Licensed Software or Documentation, and Licensee shall return to Keystone Systems all licensed materials, postage prepaid. Licensee hereby agrees to indemnify and hold Keystone Systems harmless from any breach of this Agreement or the License.

LICENSE AGREEMENT (cont'd)

5. WARRANTIES. a) Limited Warranty on Distribution Media. For a period of sixty (60) days following the date of delivery of the Licensed Software and Documentation to Licensee as the original licensee, if evidenced by Licensee's receipt as such, (the Warranty Period) Keystone Systems warrants the distribution media on which the Licensed Software is embodied to be free from defects in materials and workmanship under normal use. The warranty is personal to Licensee, and no warranty is made to Licensee's transferees. **b) No Other Warranties. Except as expressly provided in Section 5.a. for distribution media during the Warranty Period, Keystone Systems specifically disclaims all other warranties, and all materials and information provided by Keystone Systems (including, but not limited to, the Licensed Software and Documentation) are provided solely on an AS IS basis without warranties of any kind, such as warranties of merchantability or fitness for any particular purpose. The entire risk of quality and performance is with Licensee, and the Licensed Software and Documentation are not represented to be error-free. If the Licensed Software or Documentation prove to be defective, Licensee assumes the entire cost of all servicing, correction or repair.**

6. REMEDY FOR DEFECTIVE DISTRIBUTION MEDIA. Licensee's sole and exclusive remedy in the event of a defect in a warranted item is expressly limited to replacement of the defective distribution media. To receive a replacement distribution media, Licensee must send the defective distribution media, with proof of purchase, to Keystone Systems at the address indicated above, postage prepaid and postmarked within the Warranty Period. In no event shall Keystone Systems be liable for any other obligations or liabilities including, but not limited to, liability for damages (whether general or special, direct or indirect, consequential, incidental, exemplary), or for any claim for the loss of profits, business or information, or damage to good will even if Keystone Systems has been advised of the possibility of such damages. In any event, Keystone Systems's maximum liability shall be limited to the amount of the purchase price.

7. U.S. GOVERNMENT RESTRICTED RIGHTS LEGEND. The Licensed Software and Documentation have been developed exclusively at private expense, and are provided with RESTRICTED RIGHTS. Use, duplication or disclosure by the Government is subject to restrictions as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer Licensed Software clause at DFARS 252.227-7013. Keystone Systems is the Contractor, and is located at the above address.

8. MISCELLANEOUS. This Agreement shall be considered severable, and if for any reason any term or condition is determined to be invalid, illegal or unenforceable under current or future law, such invalidity shall not impair the operation of, or otherwise effect, the valid terms and conditions of this Agreement, so long as the intent of this Agreement is maintained. This Agreement shall be governed by, construed and enforced in accordance with the laws of the Commonwealth of Pennsylvania, with the exception of its conflict of law provisions. The parties consent to the personal jurisdiction of the Commonwealth of Pennsylvania and agree that any legal proceedings arising out of this Agreement shall be conducted solely in such Commonwealth. No action, regardless of form, arising out of this Agreement may be brought by either party more than one (1) year after a claim has accrued.
